- We will not initiate contact with any public school, its affiliate, or a social service organization without first contacting personnel of CCS. Furthermore, we will notify the school of any contact initiated by such organizations regarding our family. We realize that failure to do so may jeopardize our continued enrollment. _____
- We realize that Calvary Christian School is not a legal organization, does not provide legal representation, and does not retain an attorney on our or our child(ren)'s behalf. _____
- We understand that termination from enrollment could result from but not limited to the following actions: failure to pay tuition on time, turn in paperwork as required, or not providing the school with a current address and telephone number. _____
- We also understand that Calvary Christian School personnel is legally bound to notify the Board of Education upon the dismissal or withdrawal of any child(ren) from our school system. _____
- Lastly, we agree that enrollment and participation with CCS is voluntary, and that this contract may be terminated at any time by either party. _____
